Confirmation table for tax payment methods and recipient information.

7 給与(日給)等所得者の収入状況

Table for reporting income from employment (salary, daily wages, etc.). Includes fields for employer name, address, phone number, and a monthly breakdown of income and deductions.

8 事業所得(営業・農業所得)

Table for reporting business income (operating and agricultural). Includes a monthly breakdown of sales, expenses, and net income, with summary rows for total and tax-eligible amounts.

9 不動産所得

Table for reporting real estate income. Includes a monthly breakdown of gross income and expenses, with summary rows for total and net income.

10 事業専従者に関する事項

Table for reporting family members who are full-time employees of the taxpayer. Includes fields for name, address, birth date, and the amount of support provided.

11 特定上場株式等の配当所得・特定上場株式等の譲渡所得(源泉徴収がある特定口座)に関する事項

Table for reporting dividends from listed companies and capital gains from transfers of listed stocks. Includes checkboxes for reporting requirements and fields for asset details.

13 総合譲渡・一時所得の所得金額に関する事項

Table for reporting capital gains from transfers and one-time income. Includes a breakdown of income and expenses for short-term and long-term transfers, and a calculation for one-time income.

14 雑所得(公的年金等以外)に関する事項

Table for reporting miscellaneous income (excluding public pensions, etc.). Includes a breakdown of income and expenses for various types of income.

15 別居の扶養親族に関する事項

Table for reporting family members who are supported by the taxpayer while living separately. Includes fields for name, address, birth date, and support amount.

16 配当に関する事項

Table for reporting dividends received. Includes fields for the source of income, the amount received, and the tax amount.

17 配当割額又は株式譲渡所得割額の控除に関する事項

Table for reporting tax credits for dividends and capital gains from stock transfers. Includes fields for the amount of the credit and the tax amount.

18 所得金額調整控除に関する事項

Table for reporting adjustments to income tax. Includes fields for the taxpayer's name, address, birth date, and the amount of the adjustment.

Form for reporting family members who had no income in the previous year. Includes fields for name, address, date of birth, and the reason for having no income.
